- Your four submitted images are judged as a body of work
- Images should be prepared and submitted as for a client. **SUBMIT ONLY YOUR BEST WORK!**
- Each submitted image must be of a different child or at least taken in different years
- Submissions must be made on this 2-page SKPA Photo Submission Form with directions carefully followed
- Prints must be client-ready, printed as 8x10 images, accompanied by printed entry form

Review and Evaluation Process Photographic submissions will be juried to determine acceptability. Please allow 4-6 weeks for notification. If a photograph is rejected, a critique is provided to help you improve for future submissions.

Your submission packet must include: 1) Signed copy of this form, 2) 4 - 8x10 UNMOUNTED prints of your own work, 3) CD with images and completed digital version of this form, 4) 3 referral letters about you and your work from parents 5) SKPA photo release or own for each image. Digital images must be 8x10 @ 300 res with the following information in the file name: **your last name + image number + disorder (ex: smith-2-autism.jpg)**
